WCWS meeting at the Grand Junction Art Center. Lunch provided by Delta/Montrose members. Meeting was called to order by President Virginia Blackstock. About 20 members were present and 4 guests.

Members can get their own web page to post 4, 5, or 6 paintings for \$25, \$27.50, or \$30 per year. They are working on a digital entry form we can use in future shows.
